Benefits Planners can empower beneficiaries of public benefits to make informed decisions around work, income and benefits. This guide was created to increase awareness regarding Benefit Planning services and to connect people with Benefit Planners.

Benefits Planning is available in Colorado to a wide range of people with disabilities: from individuals who are already working or know they want to work and get rid of their benefits, to those who are not even sure if work is right for them - and everyone in between! Whether you're just starting to consider work or you're already working, this guide can help you figure out the best resource for your situation.

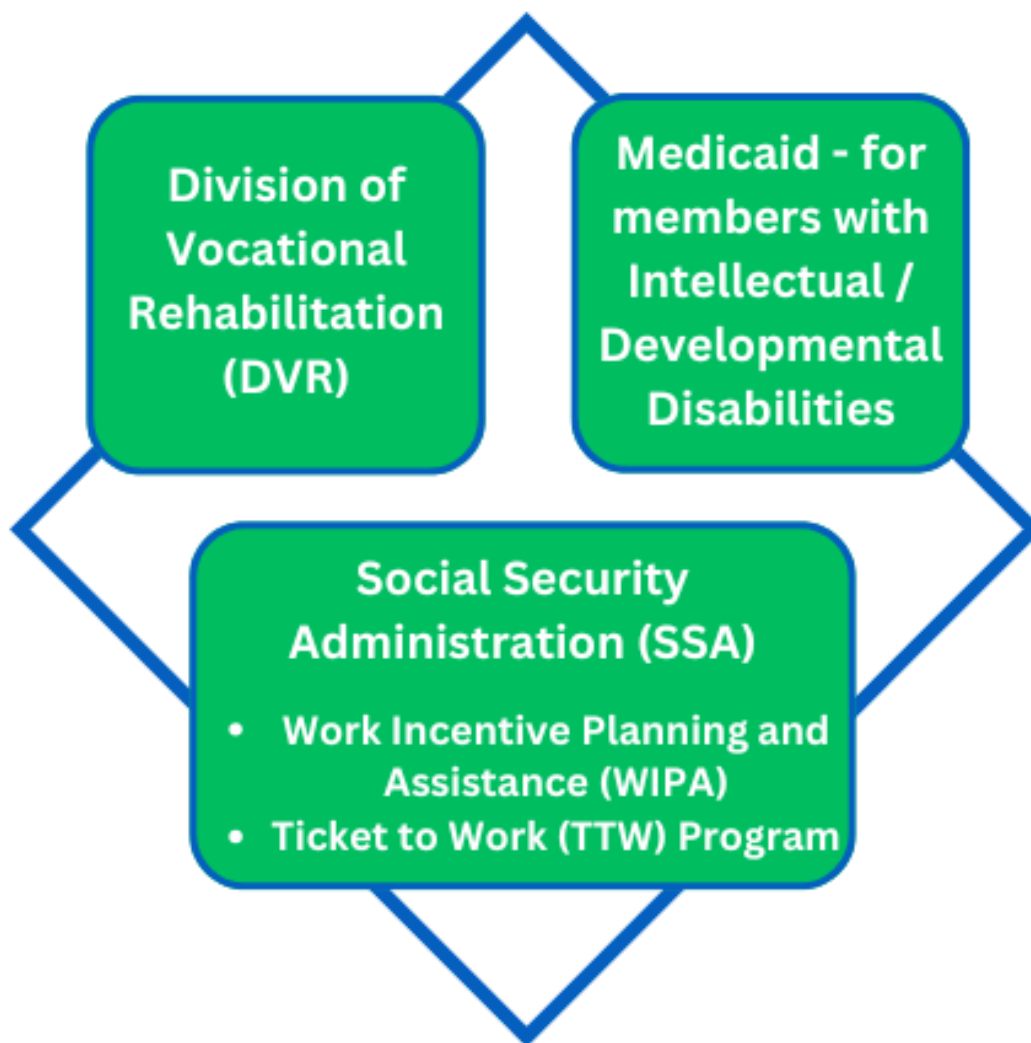

Where to Find Benefits Planning at a Glance

Each of the following programs fund Benefits Planning services for eligible individuals. Please see the full [Sources and Eligibility Requirements for Benefits Planning in Colorado](#) for more detail regarding eligibility, services offered, and how to get connected with the program that's right for you.



What are Benefits?

Benefits are government programs provided to people based on disability and/or financial need. Examples of benefits include but are not limited to:

- Supplemental Security Income (SSI) and Social Security Disability Insurance (SSDI)
- Local public benefits like: Energy Assistance (LEAP), Temporary Assistance for Needy Families (TANF), Aid to Needy Disabled (AND), Supplemental Nutrition Assistance Program (SNAP/food stamps)
- Housing assistance
- Health insurance (Medicaid/Medicare)
- Medicaid Home and Community-Based Services (HCBS) Waivers

What is Benefits Planning?

Benefits Planning (also called Benefits Counseling) is a service that informs individuals with disabilities about the impact of work income on their benefits so they can decide if they want to work, how much to work, which benefits they need to keep and which benefits they can try to reduce or give up so they can make more money. Benefits Planning is provided by an expert called a Certified Benefits Planner. The Benefits Planner creates a written report called a Benefits Summary and Analysis (BS&A).

Benefits Planning helps people receiving the service understand:

- The benefits they receive and why they receive them
- How employment impacts their cash benefits, public assistance, and health insurance
- How to reduce the impact of their earned income on their benefits (known as “work incentives”)
- How to report income for each benefit and public assistance program
- How to save money and build assets

Benefits Planning addresses the fears and concerns many individuals, their families, and support teams have about losing benefits if they start work, get a raise, or change positions.



When to get Benefits Planning?

- If you've never considered work because you are afraid you'll lose your benefits
- If you or your team think work would disrupt the supports/services you have
- Before looking for a job or going to school
- While looking for a job
- When working with a Division of Vocational Rehabilitation (DVR)
- When starting a new job
- If you're working and changes occur like getting a raise, a new position, or losing your job
- If you are 14 years old or older
- **ANYTIME employment is part of the conversation!**

What to expect from a Benefits Planner?

- A meeting with you and anyone you want with the Benefits Planner. In that meeting, you can share what's important to you about benefits and work and the person you bring with you can help.
- You can choose if you want to meet in person or virtually on the computer.
- The Benefits Planner will use the information you share to:
 - Provide a list of all of the benefits you have now (The planner will verify all of your benefits)
 - Write a report which includes your income goals and how those goals impact your benefits so you can build the life you want and keep the benefits you need.
- The report is called A Benefits Summary and Analysis (BSA) which summarizes all of the information learned from the Benefits Planner, including how work income affects each benefit
 - This report (the BSA) can include a Work Incentive Plan with a timeline of action steps when needed.
 - The BSA includes wage reporting instructions
 - You will get a written copy of the plan and the Benefits Planner will review the plan with you
- Benefits Planners can provide ongoing support for changes in your income or benefits (although you may need to get a new authorization).



Sources and Eligibility Requirements for Benefits Planning in Colorado

1. Colorado Division of Vocational Rehabilitation (DVR)

Tip: If you meet DVR eligibility requirements, they can provide Benefits Planning and help you find a job or career that's right for you! Even if you are already working, DVR may be an option for you. Benefits Planning services are available as soon as you are determined eligible for services.

Requirements to get Benefits Planning from DVR :

- Have a disability that makes it hard to get or keep a job
- Eligible for DVR services
- Ages 15 and above
- Receive any type of public benefit (**you do not have to be receiving SSI/SSDI**)
- You are working or are thinking about working

Cost: No Charge, but must be determined eligible for DVR Services.

DVR contracts with vendors who are Certified Benefits Planners; these vendors are [listed below](#).

GET STARTED – If you are enrolled with DVR, tell your counselor you would like to talk to a Benefits Planner. If you are not enrolled with DVR, complete the [DVR Referral Form](#) and someone from DVR will contact you within 5 business days.

2. Medicaid (also called Health First Colorado) Developmental Disabilities (DD) and Supported Living Services (SLS) Waivers

Tip: If you're on one of these Waivers and think you might want to work (or make more money), talk to your Case Manager about getting Benefits Planning.

Requirements to get Benefits Planning through Medicaid DD and SLS Waivers:

- Must have an Intellectual/Developmental Disability (IDD) and be enrolled in the Developmental Disabilities (DD) or the Supported Living Services (SLS) Medicaid Waivers, or the State SLS Program
- If a Waiver member is actively working with DVR, then they must get Benefits Planning through DVR.

Cost: No Charge, but must be enrolled in the DD or SLS Medicaid Waivers or State SLS program.



GET STARTED – Contact your DD or SLS Waiver Case Manager. If you don't know who your Case Manager is, contact your Case Management Agency (CMA). If you are unsure about your CMA, visit the [Case Management Directory webpage](#). Medicaid contracts with vendors who are certified Benefits Planners; these vendors are [listed below](#).

3. SSA's Work Incentive Planning and Assistance (WIPA)

Tip: if you're on SSI or SSDI and only need benefits planning (no employment services), WIPA is a good option for Benefits Planning Services.

Requirements to get Benefits Planning from the WIPA:

- Must be getting Social Security disability benefits (SSI/SSDI)
- Must be at least 14 years old
- Not yet eligible for full retirement benefits

Note: WIPA prioritizes services for individuals described below. If this does not describe you, you will likely be put on a waitlist and may want to get services through DVR instead.

WIPA Program priorities:

- Receiving SSI/SSDI and employed, self-employed, seriously considering employment
- Receiving SSI/SSDI and in school or training that will lead to employment and will finish within 12 months
- Receiving SSI/SSDI and are a student between 14 and 24
- Military Veterans

Cost: No charge, but must be receiving at least one Social Security disability benefit (either SSI or SSDI).

GET STARTED – Call the Ticket To Work Helpline at 1-866-968-7842 / 1-866-833-2967 (TTY) and tell them you would like to connect to your local WIPA benefits planners at [Ability Connection Colorado](#).

Note: SSA's Ticket to Work (TTW) program is another option for people receiving SSI or SSDI [who are ready to work and get off those benefits](#). SSA Contracts with Employment Networks to deliver Ticket to Work services. Contact the Ticket to Work Helpline at 1-866-968-7842 / 1-866-833-2967 (TTY) to determine eligibility and to be connected to an Employment Network.

Tip: If you're working or close to working and are on SSI or SSDI, TTW helpline is a good place for answers to quick questions if you don't need a detailed benefits plan. 1-866-968-7842 / 1-866-833-2967 (TTY)
